

PRIVACY NOTICE

This privacy notice discloses the privacy practices for the Motorcycle Rider Training Center, LLC (<http://www.mrtcridered.com>) and referenced throughout the remainder of this document as MRTC. This privacy notice applies to information collected by this website. It will notify you of the following: (1) What personally identifiable information is collected from you through the MRTC website, how it is used and with whom it may be shared. (2) What choices are available to you regarding the use of your data. (3) The security procedures in place to protect the misuse of your information and (4) How you can correct any inaccuracies in the information.

Information Collection, Use and Sharing

MRTC requests information from you on our registration form. To enroll with MRTC, you must provide contact information (ex. mailing address, email address, phone number, etc.) and financial information (ex. credit card number/expiration date) to secure/confirm a position in a specific class. This information is used for billing purposes and to complete your registration process. If we have trouble processing an order, we will use this information to contact you.

MRTC is the sole owner of the information collected on this site. MRTC only has access to/collect information that you voluntarily give us via email or other direct contact from you. MRTC will not sell or rent this information to anyone.

MRTC will use your information to respond to you, regarding the reason you contacted us. MRTC will not share your information with any third party outside of our organization, other than as necessary to provide course completion status to required agencies.

Unless you ask us not to, MRTC may contact you via email in the future to inform you about specials, new services, or changes to this privacy policy.

Your Access to and Control Over Information

You may opt out of any future contacts with MRTC at any time. You can do the following at any time by contacting MRTC via the email address or phone number given on our website: (1) See what data we have about you, if any, (2) Change/correct any data we have about you, (3) Have us delete any data we have about you, and (4) Express any concerns you have about our use of your data.

Security of Your Information

MRTC takes extreme precautions to protect your information. When you submit sensitive information via our website, your information is protected both online and offline. Whenever MRTC collects sensitive information (such as credit card data), that information is encrypted and transmitted to us in a very secure manner. You can verify this by looking for a “closed lock” icon at the bottom of your web browser, or by looking for “https” at the beginning of the address of our web page.

While we use encryption to protect sensitive information transmitted online, MRTC also protects your information offline. Only an MRTC employee who may need the information to perform a specific task (ex. billing or customer service) would be granted access to personally identifiable information. The computers/servers in which MRTC stores personally identifiable information are kept in a secure environment.

This website contains links to other sites. Please be aware that MRTC is not responsible for the content or privacy practices of such other sites. MRTC encourages our users to be aware when they leave our site to link to another site and to read the privacy statements of any other site that collects personally identifiable information.
